1. **Welcome**: The Special General Meeting was held between servings at the IBM QCC Annual Dinner, which had started at 19:00. The President, Ed Greenaway called the meeting and members moved to the end of the function area, leaving non-members at the tables in the dining area.

- 2. **President**: opened the meeting then handed over to the Treasurer.
- 3. Treasurer: explained that, now IBM is no longer providing any support for the QCC, the Committee had considered how to keep it operating. It calculates that annual expenses are about \$1,700; thus the Club requires sufficient income to cover these expenses. The Committee has assumed that 90-100 members would be willing to pay an annual subscription fee which the Committee recommends be set for next year at \$20.00.

Tom then invited questions. There being no questions members were invited to fill in the voting forms they had been given prior to the meeting. The voting forms contained the following resolutions:

- 1. There will be no joining fee.
- 2. The annual membership subscription for QCC Members for the 2019/2020 year to be set at \$20.00.
- 3. The annual membership subscription for QCC Partners (surviving partners of deceased members) for the 2019/2020 year to be set at \$10.00.
- 4. The annual membership subscription for Associate Members for the 2019/2020 year to be set at zero.
- 5. Those current members who decide not to pay the membership subscription be classified as Associate Members.
- 6. The due date for payment of the annual subscription will be 1 July 2019.
- 4. **Voting:** The members filled in their forms and returned them,

The meeting closed at 20:35 and members returned to their seats, leaving the Committee to count the votes. There were a total of 40 votes plus 9 proxies to the President. All votes were cast in favour of the recommendation.

The Secretary asked one of the non-members, Haydn Caris, to independently verify both the count and the vote. He did this.
